

### **Mr. Scott Avedisian- Deputy to General Convention**

Scott Avedisian, Chief Executive Officer of the Rhode Island Public Transit Authority, was born in Warwick and educated in the public schools of Warwick and Washington, DC. He was graduated from Providence College, received his master's in public administration from Roger Williams University. Prior to heading up RIPTA, Scott was Mayor of the City of Warwick for 18 years and a member of the Warwick City Council for nine years.

A lifelong Episcopalian, Scott served for three years as the President of The Standing Committee of the Episcopal Diocese of Rhode Island. He served for a year as a member before becoming President. In this position, he helped lead the Diocese during the election of Bishop W. Nicholas Knisely. He currently serves as a member of the Cathedral Chapter. Avedisian has also served as the Chancellor of the Diocese and as the Parliamentarian of Diocesan Convention. He previously was appointed by Bishop Geralyn Wolf to Diocesan Council. He has also served as a Judge on the Ecclesiastical Trial Court and a member of the Committee on Resolutions. He has been a delegate to Diocesan Convention for more than a decade.

Avedisian was elected as a Deputy to the 2015 and 2018 General Conventions and was appointed as a first-time Deputy to the Dispatch of Business Committee. A lifelong member of Trinity Episcopal Church in Pawtuxet Village, Avedisian also served two different stints on the vestry at Trinity – for a total of 12 years. He also served as Senior Warden for an additional three years.

### **The Rev. Sunil Chandy- Commission on Congregational Development Deputy to General Convention**

Fr. Sunil Chandy is Rector of Christ Church Westerly, an active, creative, multi-staff, program church. In our diocese he served as Deputy to General Convention, Program and Budget, Project Resource and is active in the Narragansett Deanery. Before Rhode Island, he served two dioceses (Newark and NJ) He served as President of Standing Committee, Commission on Ministry and Congregational Development and as Deputy to General Convention.

He loves his vocation and is especially fond of evangelism. Sunil is a recent "empty nester." Although he enjoys binge watching TV shows, he craves work that is important and meaningful! He seeks to serve on the Commission on Congregational Development and as a deputy to General Convention.

### **Ms. Laura E. Clark- Deputy to General Convention**

Since my baptism at St. Matthew's, Jamestown, I have served as a church schoolteacher, confirmation class mentor, vestry member and currently as a thrift shop volunteer and choir member. Outside of St. Matthew's, my main connection to the Diocese is through the Episcopal Conference Center (ECC). I co-led a parenting conference last fall and am a visiting staff member in the summer. ## **Ms. Deborah Collins-Commission on Congregational Development**

After moving to Rhode Island from Virginia in 1997 to take a position at Brown University, Deborah became a member of St. Luke's Episcopal Church, East Greenwich. At Brown, Deborah was Director of Research and Evaluation for the Northeast Regional Education Laboratory and, later, Associate Director of the Leadership Alliance. Her educational research career largely focused on issues of equity and diversity. St. Luke's became a constant, loving source of community to her and helped balance and inform both her faith and intellectual development. Serving on the vestry, singing in the choir, and participating in the worship and service of St. Luke's were primary activities for Deborah until her retirement from Brown. At that time, seeking to expand the church's reach into the community, she took on leadership of St. Luke's newcomer program and collaborations with local community organizations. This later led to a one-year term with the Diocesan Commission on Congregational Development, where she has enjoyed learning about the Diocese and its work.

## **The Rev. Greta Getlein Commission on Finance**

I am the vicar at St. Paul's, Pawtucket. I've been in this diocese now for 5 years and have really enjoyed taking my part "in the councils of the church" by serving on the Standing Committee for four years (one as Secretary, this year as President), and serving as the liturgical coordinator for diocesan liturgies for three years. In our diocese I have served on the leadership team for Happening, as the Dean of the Narragansett Deanery, as a member of Diocesan Council, as a Deputy to General Convention in 2015, as the Chair of our Deputation to General Convention in 2018, and as a member and president of the Standing Committee.

**The Venerable Janice L. Grinnell- Deputy to General Convention  
Delegate to Provincial Synod**

Jan Grinnell is Archdeacon and has been ordained Deacon for 28 years, and has served liturgically at St. Michael's, Bristol; Trinity Church in Newport; St. Paul's, Wickford; and St. Augustine's at URI, where she was Chaplain to the campus. She is one of the formation directors for the Province I School for Deacons. She serves on the Board of Directors for the Association for Episcopal Deacons (AED), is a founding member and Board member of the Center for Reconciliation, and a Board member of Trinity Village (a new addiction recovery house for women and children in Portsmouth, RI). She has served as the Province 1 Synod deputy since 2013 and served on the Commission on Ministry. She had been a clergy deputy to General Convention (GC) twice in 2015 and 2018; and, served on the 2015 GC Drug and Alcohol and the 2018 Racial Reconciliation Legislative Committees. Another one of Jan's contributions to the Diocese was facilitating the Yes<sup>3</sup>! Curriculum to help participants identify and embrace their God given purpose. Jan's secular employment over the years has focused on IT consulting. She has worked for several large companies and has owned her own certified Woman Owned Enterprise (WBE), Grinnell Appreciative Consulting, LLC for eleven years. Jan is married to Ann Hamm and they have four married children and three grandchildren.

**The Rev. Elizabeth Habecker- Standing Committee**

A proud native of New Jersey, I was born and raised in Montclair, New Jersey. My University days were spent in Ohio where I lived for some time and taught high school English.
