If the requisite three-fourths is not obtained, the same procedure shall be repeated for the election of another candidate."; 2) Addition of a Reports Section according to Episcopal Diocese of Rhode Island Canon 10, Section 22: "Do the bylaws require that the parish, through its rector or, if none, its wardens, prepare annual reports for each preceding year ending December 31? Do the bylaws require the report be in the form prescribed by the General Convention and contain the information as required by the Canons of the Episcopal Church? Do the bylaws require that the report be sent to the bishop, in duplicate, by no later than February 1?"; and 3) careful proofreading of the final document. Motion: Becky/David
